Advice regarding licence type, noting that no application has been submitted to ARPANSA officially to date:

s47C

- The licence application needs to provide assessment of the interface between the CIF operations and the s22 partner. An example of this is demonstrating that withdrawing liquid coolant directly from the coolant system of the s22 partner submarine does not impact upon the OPSMAN1 safety case. This level of assessment and detail is appropriate to the staged licensing facility approach.
- The proposed operations will likely require radiological airborne discharge limits to be imposed on the CIF.
 As a precedent there are no waste management facilities which require airborne discharge limits which are currently licensed under a Source Licence.
